

14.2 Substantive change

The institution has a policy and procedure to ensure that all substantive changes are reported in accordance with SACSCOC policy.

Compliance Judgment: In Compliance

Rationale

Substantive change policy. As a member institution of the University of South Carolina System, USC Aiken complies with [system policy ACAF-2.00](#)^[1] that pertains to creation and revisions to academic programs, and [system policy ACAF-2.11](#)^[2] that pertains to substantive change. Policy ACAF-2.11 is a comprehensive policy that covers myriad substantive changes including:

- Initiating coursework or programs at a more advanced level than currently approved;
- Initiating a branch campus;
- Altering significantly the educational mission of the institution;
- Initiating a merger or consolidation with another institution;
- Relocating a main or branch campus;
- Changing governance, ownership, control, or legal status of an institution;
- Changing from clock hours to credit hours;
- Adding a permanent location at a site where the institution is conducting a teach-out for students from another institution that is closing;
- Closing a branch campus or an institution;
- Expanding program offerings at current degree level;
- Initiating joint degrees with another institution;
- Initiating a certificate program at employer's request and on short notice;
- Initiating other certificate programs;
- Initiating off-campus sites;

- Expanding program offerings at previously approved off-campus sites;
- Relocating an off-campus instructional site;
- Initiating online programs or other programs where the faculty and students are not in the same location that are significantly different from current online offerings;
- Initiating degree completion programs;
- Initiating programs or courses offered through contractual agreement or consortium;
- Entering into a contract with an entity not certified to participate in USDOE Title IV programs;
- Acquiring any program or site from another institution;
- Altering the length of a program significantly; and
- Closing a program or approved off-campus site.

Procedure. The creation of new or substantive revision of existing academic programs at USC Aiken involves four steps. First, a complete draft program proposal is developed by the academic unit, dean, or Library Director in consultation with the following USC Aiken officers who will be asked to comment on the campus resources needed to support the program:

- Executive Vice Chancellor for Academic Affairs and Provost
- Vice Chancellor for Information Technology
- Associate Vice Chancellor for Enrollment Management
- Senior University Facilities Executive
- Vice Chancellor for Finance and Administration

Second, the complete draft program proposal is reviewed and approved by the following USC Aiken committees prior to distribution to the USC system and S.C. Commission on Higher Education reviewers:

- College of Sciences and Engineering or College of Arts, Humanities, and Social Sciences Coordinating Council (if appropriate)

- Academic Council
- University Planning Committee
- Courses and Curricula Committee or Graduate Advisory Council
- Faculty Assembly

Third, a proposal that has been reviewed and approved by the faculty governance structure at USC Aiken is reviewed and approved by the Chancellor before being sent to the President, Board of Trustees, and the S.C. Commission on Higher Education, as specified in ACAF 2.00, Sections I.B.3.b and I.B.3.

Finally, the USC Aiken Provost and Executive Vice Chancellor for Academic Affairs works with the SACSCOC Liaison to prepare letters of notification or, if required, a prospectus. The USC Aiken Provost and Executive Vice Chancellor for Academic Affairs is responsible for submitting proposals to SACSCOC for approval of new academic programs and substantive changes to academic programs six months before implementation.

Publication and dissemination of policies and procedures. The current relevant policies were last modified and approved by the Provost in March of 2015. They are publically accessible via the [USC System Policy and Procedures website](#).^[3] The procedures are also published in the [Faculty Manual](#).^[4]

Evidence of compliance with policies and procedures. Table 14.2 presents all current academic programs offerings, including sites and delivery modes, and programs that were in place at the time of University of South Carolina Aiken's last reaffirmation of accreditation. Links are provided to documentation of all changes to program offerings over the past ten years. In addition, notifications to SACSCOC regarding a new mission statement and an emergency relocation of instruction are included. The documentation demonstrates that the University has notified the Commission of all changes in accordance with the substantive change policy.
