Non-Compliance

The Off-Site Reaffirmation Committee reviewed the Faculty Manual sections pertaining to responsibilities for academic deans, which includes review of curricula and programs, and the responsibilities for department chairs, which includes responsibilities for reviewing curricula and conducting program assessment. Supporting documentation included the appointment letter for the Art Program Director which assigns responsibility for program curricula modifications and analysis of assessment data.

The institution's compliance narrative includes Table 6.2.c Program Descriptions, Appointment Letters, CVs, and Qualifications of Program Coordinators. In addition, letters of appointment for departmental chairs who administer departments offering programs in more than one discipline indicate program coordination responsibility is assigned to the department chair for all programs offered by the department. The Off-Site Reaffirmation Committee found further information is needed to support appropriate credentials for the program coordinators listed below:

- Bachelor of Arts (Biology) and Bachelor of Science (Biology);
 Coordinator has PhD in Immunology
- Bachelor of Arts (Political Science); Coordinator has PhD in History
- Bachelor of Arts in Education (Early Childhood Education); Coordinator has EdD Education
- Bachelor of Arts in Education (Early Childhood Education); Coordinator has PhD Teacher Education
- Bachelor of Science (Applied Computer Science and the Applied Computer Science online program): Coordinator has PhD in Mathematics
- Bachelor of Science (Clinical Laboratory Science); Coordinator has PhD in Immunology
- Master of Education (Educator Leadership); Coordinator has PhD in Learning and Design Technology

The Off-Site Reaffirmation Committee could not find an institutional policy or job description related to the qualifying credentials and expected activities of program coordinators.
